SSP Indicators Project Background

Started in 2023 with funding from CDC as part of the National Harm Reduction Technical Assistance Center (NHRTAC)

Aimed to develop community informed indicators that can be recommended to SSPs and harm reduction programs

As of December 2023, NACCHO and UW are no longer part of NHRTAC

SSP Indicators Project is continuing until July, 2024 under different CDC funding

Goals for Current Phase of SSP Indicators

1. Hold Salons to:

-Create space to discuss common data issues brought up by community

-Learn from each other and document creative solutions

2. Create implementation guide for indicators, coming out July 2024

SHaRP Team Values and Guiding Principles for Data

- Services first, data second
- Participant confidentiality (anonymity if possible)
- Minimize burden on programs and participants
- Only collect data that can be used to benefit people who use drugs and programs
- No one size fits all

Overdose Prevention Indicators

Program services and activities directed towards preventing fatal overdose

- Count of naloxone doses distributed
 - Low-barrier indicator
 - May be collected through inventory or encounter data

Overdose Prevention: Participant Overdose Experience

An indicator to document participants' experience with themselves overdosing

Sensitive indicator

- May help programs...
 - Document the physical and psychological burden of overdose
 - Advocate for policies that decrease population level overdose risk

Overdose Prevention: Reported Overdose Reversals

 An indicator to document participants' experience with reversing an overdose on someone else

- May help programs...
 - Document the physical and psychological burden of overdose
 - Advocate for policies that support the community labor of people who use drugs

Structural Violence

• The ways that local, regional, and national systems and institutions, including economic, political, cultural, and legal institutions, affect the lives and health of participants

Structural Violence: Participant Housing Status

- May help programs...
 - Ensure they are reaching populations that have been most marginalized
 - Document the physical and psychological burden of being unhoused
 - Advocate for policies that support housing people who use drugs

Structural Violence: Participant Interactions with Law Enforcement

- May help programs...
 - Document the violence that participants face
 - Develop services to help prevent police interactions
 - Organize across local spaces to work against police violence

Collecting Sensitive Data

- Frequency of collection don't have to ask every time!

- Collecting vs. receiving data (always ask consent!)
- Pilot testing
- Anonymous and deidentified
